The **AUTHORITY OF THE FREEPORT AREA OF BATAAN (AFAB)**, with office address at the Second Floor, AFAB Administration Building, Freeport Area of Bataan, Mariveles, Bataan, represented herein by its Administrator and Chief Executive Officer, **MOHAMMED HUSSEIN P. PANGANDAMAN**, pursuant to Board Resolution No. 2023-31 issued on 29 May 2023, hereto attached as *Annex "A"*, and hereinafter called "the Procuring Entity and/or Entity" of the one part;

- and -

BATAAN ECONOMIC ZONE COMMUNITY MULTI-PURPOSE COOPERATIVE, with office address at 2nd Floor, AFAB, Administration Building, FAB, Mariveles, Bataan, represented herein by its General Manager, **JOSUE C. DATU**, who is likewise duly authorized pursuant to Secretary's Certificate dated 20 December 2023, hereto attached as *Annex "B"*, and hereinafter called "the Supplier and/or Winning Bidder" of the other part.

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly the **Service Contract of Manpower, Tools and Equipment for the Collection, Hauling of Residual Solid Waste from Freeport Area of Bataan (FAB) Locators, Facilities, Parks and Road Networks to the FAB Transfer Station and the Manpower and Supervision for the Sanitation Maintenance of FAB Grounds** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Fourteen Million Nine Hundred Thirty Thousand Four Hundred Ninety One Pesos and Fifty Nine Centavos (Php 14,930,491.59)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - a. Philippine Bidding Documents (PBDs);

- i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
- b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- c. Performance Security;
- d. Notice of Award of Contract and the Bidder's conforme thereto; and
- e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs, particularly the AFAB-Bids and Awards Committee (BAC) Resolution No. G-02 S. 2024 dated 24 January 2024 recommending the Award of the Contract to the winning bidder, and the Certificate of Availability of Funds, which are hereto attached as *Annexes "C" and "D"*, respectively, and made integral parts of this Agreement.

Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

- 3. In consideration for the sum of *Fourteen Million Nine Hundred Thirty Thousand Four Hundred Ninety One Pesos and Fifty Nine Centavos (Php 14,930,491.59)* or such other sums as may be ascertained, **BATAAN ECONOMIC ZONE COMMUNITY MULTI-PURPOSE COOPERATIVE** agrees to satisfactorily supply the goods and execute services in accordance with its Bid.
- 4. The **AUTHORITY OF THE FREEPORT AREA OF BATAAN** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.

- b. To use the Bid Amount as Read of Php 14,930,491.59 as the contract amount per Section 34.4 of the RIRR of RA 9184;
- c. To recommend for approval by the Administrator and Chief Executive Officer of the Authority of the Freeport Area of Bataan as Head of the Procuring Entity of the foregoing findings.



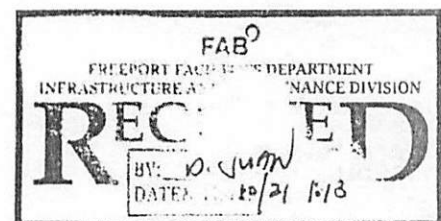


